## **Data Summary**

Thurston County is comprised of seven communities with two reservations and has an estimated population of 7,171 with approximately 2,862 of them being juveniles. In assessment of the data, it has shown there is not an overabundance of arrest and long-term detentions; however, there is a definite need for the Diversion Program and mental health services programs to continue on in this County as well as other activities developing to help our juveniles of this County.

One of the primary issues identified for the county needs assessment for 2020-2021 is chronic absenteeism. Historical data reflects an increase in youth chronic absenteeism in recent years. In 2018/2019 more than 1000 students were chronically absent. This data reflects a need to address truancy within Thurston County.

Another troubling issue identified by the Thurston County needs assessment reflected youth who reported mental health symptoms and substance use. More than 20% of high school seniors in Thurston County have considered or attempted suicide which is indicative of a serious mental health crisis in our county. More than 50% of Thurston County 10th graders reported being depressed (20 percentage points more than the Nebraska average). The Pender Public School is working to address the mental health needs of youth in our community. Pender Public Schools has made a room available for mental health practitioners to come into the school and meet with clients there. Heartland Counseling comes to the school 3 days a week and meets with 11 students. Faith Regional also comes to Pender 2 days a week and meets with 6 students. Kathy Baker also comes to the school once a week to meet with a student. These services are in addition to the counseling provided by the school counselor. The school reports that appointments with providers fill quickly and that if additional appointments were available, they would be utilized by students. Pender Public Schools had a student who committed suicide last school year and other students within the county have been hospitalized for suicide attempts.

Drug and alcohol use is another problem in Thurston County. 33.3% of Thurston County  $10^{th}$  graders report current marijuana use (as compared to 7.3% of Nebraska  $10^{th}$  graders). Similarly, 26.8% of  $12^{th}$  graders report current marijuana use (as compared to 13.9% of Nebraska 12th graders). Nearly a third of high school seniors report current alcohol use.
